The Public Ice-Carving Challenge, forms part of Winterlude, and takes place on Saturday, February 20<sup>th</sup> at Confederation Park on the corner of Elgin Street and Laurier Avenue, Ottawa. A block of ice measuring about 1 metre by 50 centimetres by 25 centimetres, as well as the basic tools will be provided to you to create your sculpture. Prizes will be awarded immediately following the competition.

### Equipment

Each participant will be provided with water, paper, a pencil and markers. Should participants bring their own tools, these must be pre-approved by the competition organizers. The National Capital Commission will provide basic tools for participants. Sculptors from the Canadian Ice Carvers' Society will help participants with the chainsaw for the first step in creating the sculpture, beginning at 11:30 am.



### Introductory Workshop

An introductory workshop on ice-carving will be offered to participants from 10:30 am to 11:30 am, on Saturday, February 20<sup>th</sup>.



### Theme: Winter Fun!

Title of sculpture is required. (The organizers reserve the right to disqualify contestants if the piece is of questionable taste or promotional in nature.)



### Rules

1. Minimum age for participation: 18 years.
2. Professional ice sculptors are not allowed to participate.
3. NCC employees and members of their immediate family are not permitted to register.
4. No electric tools allowed.
5. No material, accessories or dry ice may be added to the ice.
6. A total of 12 spaces are available for the competition.
7. A sound will signal the beginning and end of the challenge.
8. Send your registration form, release form and proposed sketch by February 8, 2010.
9. For safety reasons, maximum of two participants per carving. Only one participant is allowed to carve at a time (relay).
10. Specific sculpting locations are selected randomly at the start of the competition.
